

These involve a few hours work over the next three months — to certify a set of candidates for the election, then conduct the election itself. Anyone participating on these committees cannot be a candidate for elected office, nor can they be a member of the current ExComm. Thus, we need volunteers who want to help out the group but aren't ready to hold an office. If you'd like to volunteer, please contact me as soon as possible!

Obviously, with elections coming, we need candidates for office. Several of our officers cannot run for their same positions in the coming year, but of course you're welcome to run for any position. We also will most likely have a larger ExComm this coming year — our bylaws stipulate that, if we exceed 400 members at the end of August, we add two Members At Large. Our July-end roster had 398 members. Member At Large is a great way to get involved as an ExComm member with no formal duties other than attending and participating in ExComm meetings. If you'd like to run for office, you have a few options. You can contact me, and I'll

put you in contact with the Nominating Committee; you can contact them directly — contact information will be in the October 'Dillo; or you can nominate yourself as a candidate at October's Monthly Meeting.

So, in order of events: come out to the RG and have a great time with your Mensa friends, sign up for and attend the Book Sale, and get involved with the group at the ExComm level, either by helping with the elections or by becoming a candidate. You'll enjoy yourself, help out the community as well as Lonestar Mensa, and find new rewards to your membership. See you there!

August ExComm Meeting Minutes

John convened the meeting at 5:40 p.m.

We discussed the group's finances. Midge has prepared a balance sheet which will be published in the newsletter this month. The group is in good shape financially. We can also expect reimbursement from the National Office for contacting lapsed members and for sending the newsletter out for the full mailing. Our postage and printing costs will reflect the added expense but the reimbursement should cover it.

We talked about the costs of the RG. We discussed the rate we charge as well as the price breaks and the total difference between the cost of registering early or at the last minute. It was agreed that more people might register early if there were a larger difference in cost to them. However - we do not want the RG cost to prohibit attendance, so it is necessary to hold the cost down. We do expect a large number of people to register on site. SynRG had a large walk-in contingent this year as well and we have heard from a number of people who are planning to attend but have not registered. It is helpful for planning for people to register in advance - but we will not be charging higher walk-in rates to try to facilitate this.

We discussed our local scholarship winner. We need to ask Kartik for the name as National has given the OK to release that information now. We will probably print her essay in the newsletter and we may award her \$300 at a monthly meeting.

John adjourned the meeting at 6:20 pm.





Many of you probably know that the League of Women Voters is a seminal organization for getting out unbiased, nonpartisan information on current election issues. The November election is fast approaching. Therefore, we have asked the President of the League of Women Voters of Austin to talk to the group about important issues in the upcoming election.

The speaker at our September 9 meeting will be Mrs. Maxine Barkan, President of the League of Women Voters of Austin. Mrs. Barkan has chosen to speak on "Everything You Wanted to Know About the Electoral Process in Texas." She plans to discuss the League's positions on the electoral process, including campaign finance reform, judicial selection (she will bring copies of the Facts & Issues just published in the latest League study), League activities in getting out the vote, recent changes in Texas election laws, and the new electronic system for voting. She will also touch on the subject of voter apathy, and what we, as Mensans, can do to get informed people to vote.

Mrs. Barkan is a retired Registered Professional Educational Diagnostician who received her certification in that field shortly after it was established by the Texas Education Agency. She received her BA degree in Psychology from the University of Houston, and her MA degree in Special Education from Texas Woman's University. She was a faculty member of Cypress-Fairbanks Independent School District, Houston, Texas, for 15 years. She taught children and youth with learning and emotional disabilities. She was one of the early certified educational diagnosticians in the state of Texas and the first diagnostician in the Cypress-Fairbanks Independent School District. She developed assessment tools to evaluate children's learning problems, supervised the district's diagnosticians, and chaired the multidisciplinary team evaluating and planning educational programs for children and youth identified as needing special services. In addition, she taught courses in special education for teacher certification for Lamar University in their off-campus programs. During her professional years, Mrs. Barkan was a member of the Council for Exceptional Children and the Texas Association for Children with Learning Disabilities. She was a founder and first president of the HoustonMetropolitan Educational Diagnostician's Association and a member and past president of the Texas Educational Diagnostician's Association. Mrs. Barkan was an educational therapist at Sagamore Hills Children's Psychiatric Hospital, Sagamore Hills, Ohio, for four years where she was a member of a multidisciplinary team working with severely emotionally disturbed 14-18 year old boys.

After her retirement, Mrs. Barkan became involved in a number of volunteer activities, including working with the Capital Area Food Bank, where she helped salvage and distribute food to social service agencies and trained volunteers. She is a commissioner on the Austin Arts Commission and has served as vice-chair, chair, currently serves as parliamentarian, and is a member of the Executive Committee. A long time member of the League of Women Voters, Mrs. Barkan has held many positions of leadership. She is the current president of the League of Women Voters of the Austin Area. She chaired a study on the Transportation System of Austin in 1996-97 that resulted in the League's advocacy for transportation issues. She is a member of the League's Speaker's Bureau. She has represented the League on two citizen's advisory committees for the Capital Metropolitan Transit Authority. Most recently, she represented the League on the Travis County Citizen's Advisory Committee on Elected Officials' Salaries, and is on a committee for the County Clerk to help educate the public about the new electronic voting devices. Mrs. Barkan has also been an Election Judge or Alternate Judge for ten years. Mrs. Barkan has served as Advocacy Vice-President for the League of Women Voters of Texas. She chaired a study on the political campaign process in Texas, and as a result, advocates for the League in the Texas State Legislature on campaign finance reform, public financing of campaigns and electronic filing of reports. Most recently, she served on a committee that studied judicial selection in Texas. Mrs. Barkan was recently awarded the President's Award for outstanding service to the League of Women Voters of Texas, and was honored for her years of service as an Arts Commissioner in a City of Austin ceremony recognizing members of boards and commissions for their length of service. Mrs. Barkan enjoys quilting, sewing, classical music, and reading as hobbies. She is married with grown children.
