Treasurer's Report Second Quarter 2007

-from Don Drumtra, Treasurer

We have had good results for the first half of our first year under the program structure. As may be seen on the Cumulative Program Summary table, revenue has exceeded expenses by \$588. All programs have been significantly below budget. In June we had an unbudgeted expenditure of \$500 for a projector to be used at our monthly programs and our RG this August. We have capitalized this expense to be depreciated over 5 years but we hope to offset the negative cash flow by revenue from our RG this August..

Last quarter I mentioned that lack of volunteers has kept our program activities and expenses low. This is still the case. We need volunteers to lead our program activities. If you are interested in volunteering for any of our programs, no matter how little the time you have to contribute, please call Janet Kres and explore the possibilities. The ExComm reviewed and approved this report and accompanying tables on July 11, 2007.

Janet called the meeting to order at 6:00 p.m. with a quorum present. Don Drumtra gave the treasurer's report.

Program Details: Revenue is below expectations for the Recruitment program. This should be corrected when we receive reimbursement for the June and July testing. Education program revenue is below projections but that should be corrected with the RG raffle proceeds. Ralph Rudolph, the new AML RVC-6, and Robin Crawford, the AML Director of Communications, have honored Ray's commitment to pay for our software upgrade. They are heroes in my book. I will report this again for the August minutes..

Balance Sheet: The RG fund is at \$4060. We have 32 registrants. An account for equipment has been added under symposia for the projector we purchased. If we do well on the AG, we can expense the projector and use the depreciation funds proposed below to the prepayment fund for the next projector.

Lonestar Mensa Programs Lonestar RG

Note: This is the sixth in a series of articles explaining the new Lonestar Mensa Budget Structure and the many new positions and opportunities available for you.

Last month we learned about the Symposia Program covering our local gatherings. In addition to local gatherings, we sponsor an annual gathering called The Lonestar Mensa Regional Gathering or LonestaRG, It is a three day long symposia—a time to get to know other Mensans, to learn from the variety of programs presented, to support the Education Program, and to have fun. The LonestaRG is large enough, important enough, and enough work that it is budgeted and managed as a separate program to ensure its success.

The LonestaRG Chair is responsible for managing the 2007 budget of \$4,400 and for chairing the RG Committee consisting of the seven subcommittee chairs listed below and other representatives that chair may invite to participate. For example, a photographer or hotel representative may be invited to be a member of the committee.

The Registrar and Registration Committee are responsible for receiving and tracking registrations up to a year prior to the AG, passing money received and other information to the Treasurer, making name tags, manning the registration desk at the RG, and resolving registration problems. The Hospitality Chair and Committee are responsible for planning for, buying, preparing, and providing food and beverages for the RG. The Chair and some committee members should have food handling expertise and certification. The Programs Chair and Committee are responsible for planning and putting together the RG programs and other activities before the RG and the care and feeding of speakers and facilitators during the RG.

The Facilities Chair and Committee are responsible for negotiating the hotel contract before the RG and supervising contract implementation during the AG. The committee members are also responsible for trash collection, coordinating volunteers, and working with the programs committee in the care and feeding of speakers and facilitators during the RG. The Publicity Chair and Committee are responsible for working with the Lonestar Mensa Publicity Officer / Media Coordinator to market and advertise the RG in various venues before the RG, for press liaison, signage, and photography during the RG, and for publicity after the RG. The Drawings, Prizes, and Awards Chair and Committee are responsible for funding raising activities before and during the RG and the awarding and distribution of prizes and certificates. The Treasurer is responsible for working with the Lonestar Mensa Treasurer in support of all financial aspects of the RG.

Currently, Paul Pierce is our RG Chair. Committee members are Ray O'Connor, Hospitality Chair, Jane Thompson, Registrar, Paul Pierce, Programs Chair, Ellen Lucasik, Facilities Chair, John Neemidge, Publicity Chair, and Don Drumtra, Treasurer. We are looking for a volunteer to chair drawings, prizes, and awards and volunteers to help during the AG. If you would like more information about the positions, or would like to volunteer to help, please contact Paul Pierce, Janet Kres, or John Neemidge.

One of the purposes of the Lonestar RG is to support our Education Program which we will explore in next month's article.

The Region 6 Report

Despite the "kerfuffle" over Birmingham, (AMC's phrase) most people seemed well fed, although not in gourmet style. Plenty of blame can be assigned, from AMC's ExCom to the AG Committee, Hotel and others. It is truly sad that this happened. A committee of past and future AG Chairs will examine how to better prevent this in the future. It appears that AMC's ExCom has no legal way to quickly react to emergencies. This must be rectified. I will note that past "kerfuffles" (such as the NYC AG in 86) were FAR worse, but most folks managed to have a good time. I did.

As a "new officer" I was required to attend some orientation sessions. I was impressed with some of the things our National Office Staff are doing, and am scratching my head over others that I consider of limited usefulness compared to costs involved. AMC does not appear of have much oversight regarding these new activities. It should. I was frankly astonished when our Executive Director explained that our prime duty as AMC Officers was to the Corporation (AML and the National Office) as "Mensa could not exist without the National Office". Pardon me, but I have not been a member for 38 years because of a feeling of duty to a Corporation.

The AMC did appoint Jeff Dommenge as my Asst RVC. Jeff will concentrate on getting improved Gen-X involvement. I thank him for volunteering.

In terms of disputes within local groups, I will remind local groups that they should have an ombudsman to try to mediate these disputes before they escalate. It's much easier to nip problems in the bud rather than when they become full blown.

I had some good chats with the leaders of some of our smaller groups. As I expected, many are in difficulty because of an aging/dying ExCom and lack of activities/participation by Gen-Xers. My first task as RVC will be to try to help these groups get back on the road to health as opposed to folding them. How much I can do along these lines depends in part on my available RVC funds. Part of these had already been committed by my predecessor, Ray O'Connor. The amount available to visit local groups, assist groups and attend RGs is disgustingly small. It really ties my hands in how much I can do. RVCs are given responsibility without support.

On a more positive note, I'd like to congratulate Nancy Park of Central Oklahoma's Mensokie for winning "outstanding Newsletter" for small groups, Roy Huff of South Texas Mensa for winning the Abbie Proctor of the Year award, South Texas Mensa for winning the Dr. Salny Award for Outstanding Service in the Area of Testing, Permian Basin for winning Class V of GOTYA (Group of the Year Award), Donald Dumtra of Lonestar Mensa for being awarded the

Chairman's Certificate of Appreciation, Gulf Coast Mensa's Website, Lori Crew's "Members Only", and CultureQuest winners (1st) Eureka, 9th Grey Matters, 17th Lonestar supernovas, and 19th Hegel's Heroes. Thannks all for a job well done.

As an RVC, I do not expect to be loved. The best I can hope for is to earn your respect. I hope that happens.
