March ExComm Meeting Minutes

March 5 2008

The regular monthly meeting of the Lonestar Mensa Executive Committee, ExComm convened on March 5, 2008, at 5:58 PM, at Northwest Community Center, 2913 Northland Dr., Austin, TX. Attending were: President, Ron Edelstein, as Chairman; Vice-President and Bylaws Committee Chairman, Don Drumtra, as secretary; Treasurer, Patty Drumtra; Members at Large, Janet Kres, Kathie Blair Lawler, and John Neemidge; and Newsletter Circulation Manager, Helen Siders.

On behalf of American Mensa Limited and the American Mensa Committee, the President presented the Local Group Service Award to Janet Kres for superior service on the local level in support of the aims and purposes of the organization. (See related article for details.)

Speaking for the Testing Coordinator, Janet announced the testing sessions scheduled for March 29 in North Austin, planned for April in Buda, and planned for October in Round Rock.


The Bylaws Committee Chairman provided the monthly Bylaws Committee report as published in the February Armadillo Literary Gazette, vol. 35, no. 3, page 6. The next Bylaws Committee meeting was scheduled for Thursday, March 13 at Central Market.

The President announced that he planned to notify members of future ExComm meetings through the newsletter calendar and via the email announcement list. He also noted that he received the 2007 Annual Financial Review Report for Lonestar Mensa from Mark Kres, CPA, as published in the February Armadillo Literary Gazette, vol. 35, no. 3, page 5.. The report's single recommendation was that "current bookkeeping practices should continue to be used." The Treasurer moved that Lonestar Mensa thank Mark for giving his time to support the local group. The motion was adopted without debate.

The Treasurer provided a report consisting of spreadsheets summarizing program revenue and expenses for February, and the account balances as of February 29, 2008. She also expressed concern about new American Mensa, Ltd., financial reporting requirements. The Ex-Comm adopted the report without debate. The monthly reports are maintained in the Treasurer's records and are available to members by request. Quarterly reports are published in the Armadillo Literary Gazette. The ExComm members discussed the vacant Lapsed Member Coordinator officer position and the problem it poses in mailing reminder letters to the estimated 100 member who are expected to forget renew their memberships on time. Helen graciously volunteered to help and the President appointed her to the position.

Helen also kindly volunteered to work out details for a spring potluck picnic for members to share their early 2008 activities. The Executive Committee members agreed that April, after tax day, and before the summer heat, would be a good time to get together for a picnic.

The meeting adjourned at 6:42 PM.

There will be an AMC Meeting on March 29th in San Francisco. The main items on the Agenda (which can be viewed on the AML website) are the budget for the upcoming fiscal year, a proposal to make Interloc part of the Bulletin, and proposed referenda items to hange how we select replacement RVCs. Engineer's Corner

Computers vs Lightning "Wow. My computer blew up in last week's thunderstorm. The geeks at the computer store said the phone modem and motherboard were fried. Apparently, lightning struck the phone wire." Ever heard a story similar to that? The fact is that lightning probably didn't hit the phone wire. Phone wiring has been underground in most of the country for many years now. The cause of this common accident lies in the electrical grounding system at the residence in question.

Many older structures had the phone system grounded at one point and the electrical system grounded at another point. A lot of phone installers would commonly carry short metal rods they would drive into the dirt to ground their phone system if the electrical ground was not in the same location. If the phone and the power are grounded at separate locations, the stage is set for a computer to fry.

Imagine that lightning strikes a tree near your improperly grounded home. In most lightning strikes, the electrons actually flow from the ground up to the cloud. Suppose 1,000 amps flow through the ground toward the tree during the strike. Some lightning strikes are several times that amount. Now, suppose there is 10Ω of resistance between the phone ground rod and the electrical ground rod. It's likely much more but it makes for easy math. Ohm's Law is that voltage equals amps multiplied by Ohms. So...(1,000 amps) x (10 Ω) = 10,000 Volts.

Here, now, sits your computer. The mother board is plugged into the electrical power and the chassis is grounded to that system. The phone modem mounted within the computer near the motherboard is plugged into the phone system and is grounded to that system. Suddenly, there is a potential difference of 10,000 volts between the phone modem and the motherboard. Pow! An arch of electrons steak across from one to the other and you now are the proud owner of worthless junk.

For years now, the National Electrical Code has required that all ancillary systems in a home (phone, CATV, ect) be grounded to the same ground point as the electrical system is. Sadly, there are still many installers who don't know the law or chose not to follow it because it's not always expedient. A couple years ago, an installer came to put a DSL line into my office so I quizzed him about where he grounded it. I was happy to hear him say that he grounded it to the metal conduit of the main electrical service. Then, two seconds later, he says "But I always carry some 4-foot ground rods with me incase the electrical service is on the other side of the house."

Naturally, I had to get out a piece of paper, draw a diagram, do the math, and explain the reason behind the electrical law (probably waving my arms the whole time). Likely, he went home and told his wife "You should have seen this crazy engineer today. I put in his DSL and he flew off on this lecture about grounding. He was even drawing pictures!"

The committee approved answers to two ideas/questions about the board and its elected officers. The committee decided that all board members should be officers with assigned duties and that the elected officers on the board should be a leader, a vice-leader and recorder, a past leader, a financial officer, and one general officer per 100 Lonestar Mensa members or fraction, less one. It is like what we have today with the addition of the Past President.

At the future meeting we plan to take up questions like what should our leader be called--LocSec, Chairman, President, Mommy, or Big Daddy? What should the other elected officers be called? How many, if any, appointed officers should be on the Board? Who should vote on the board? Should our leaders be chosen by direct or indirect vote? Should terms overlap? Which of our officers should be defined in the Bylaws (rather than in ASIEs)?


March Monthly Meeting Recap
