

June ExComm Minutes

The regular monthly meeting of the Lonestar Mensa Executive Committee (ExComm) convened at 6pm, June 3, 2009, at the Northwest Community Center, 2913 Northl&Dr., Austin, TX. Attending were: Pres. Ron Edelstein, Chair; V.P. Don Drumtra, Secretary; Treasurer Patty Drumtra; Members-at-Large Paul &erson, Kathie Lawler, & John Neemidge; Membership Committee Chair Fred Goertz, Circulation Manager Helen Siders, & member Patsy Graham. The ExComm approved without debate the May 6 ExComm minutes published in the June Armadillo Literary Gazette (ALG) page 5.

Ron announced that he had accepted the resignation of Carla Young & appointed John as LonestaRG Chair & the ExComm had by email vote confirmed the appointment effective May 27. He also announced that he had assumed the positions or Ombudsman & Arbiter until he could find volunteers for those positions.

Don reported that ExComm had adopted two emergency motions by email since the May 6 meeting: a motion to accept of Carla Young's resignation & to appoint John Neemidge to LonestaRG Chair & a motion to adopt an amendment to the st&ing rule on the 2009 ExComm Meeting Dates to schedule future meeting dates to June 3, July 8, & the first Wednesday of each month after that at the NW Recreation Center (ASIE 2009-7). He moved that ExComm ratify each decision. By separate votes, the Ex-Comm unanimously ratified the actions without debate. Patty reported that the group was currently in good financial health & provided the ExComm the details that were posted online. The ExComm adopted the report without debate. Financial reports are available to members on the LSM Website & by request; quarterly reports are also published in the ALG.

Kathie, Communications Chair, reported that the new news cycle was to begin this month, June 11, when ALG submissions are due.

Don reported for the Education Committee (EdComm) that the \$400 Lonestar Mensa annual scholarship was awarded to Pete Karagizian III. Pete also won a scholarship from MERF. The ExComm thanked the Scholarship Committee members for their hard work in selecting a winner from the many submissions & particularly to Scholarship Chair, Claudia Harbert, for her leadership of the Scholarship Program.

Fred, Kathie, & Helen led a discussion about mailings to potential members through the use of email, first class mail, & bulk mail. The discussion included management of prospective member lists as well as meeting attendance lists that are some of our sources of potential members.

They agreed to work together to develop an approach to provide information to potential members, to ensure potential members would feel welcome at our meetings if they choose to attend, & to ensure names of guests at meetings be captured. Don moved that copies of all potential member lists including meeting attendance lists shall go to the Membership Chair to facilitate the membership process. The ExComm adopted the motion without further debate (ASIE 2009-8). A testing session has been scheduled for June 13 in Round Rock.

Don reported for the Symposia Committee (SymComm) that the picnic was a wonderful success with good food & great company. The varied background & life perspectives of the picnicgoers ensured interesting conversation. The June program presented by Ron Anderson of LCRA inspired many questions from the audience.

Don, Bylaws Committee Chair, reported that the Ex-Comm approved bylaws were submitted to the AMC Bylaws Comm. on May 8 & received a response that the initial review should be completed in a month.

John, LonestaRG Chair, reported that he had appointed the members to the RG committee shown in the July ALG, page 2. John also reported that he had previously circulated a contract with among the ExComm members for comment & had responded in detail to all comments received. He moved that the ExComm authorize the President to sign a revised contract with the Wingate by Wyndham Hotel & Conference Center in Round Rock committing LSM to a guest room rate of \$89 plus tax & a total meeting room rate of \$1500-\$3000 plus tax after the responses provided were negotiated with the hotel to the President's satisfaction. The ExComm adopted the motion after debate. John announced that the next RG meeting was scheduled for 10 AM, Saturday, June 13, at the hotel.

Don moved that the standing rule on Website Information Availability be taken from the table & that further debate be postponed until the October ExComm meeting. The ExComm adopted motion without debate.

John moved that the September ExComm meeting be rescheduled for the 2nd Wednesday & that the standing rule be amended accordingly. The ExComm adopted the motion after debate (ASIE 2009-9).

Don announced the next regular monthly ExComm meetings were scheduled for 6-7 PM, July 8 (2nd Wednesday), August 5, (first Wednesday), September 9, (2nd Wednesday, & the first Wednesdays in October, November, & December, at the Northwest Recreation Center multipurpose room. ExComm meetings are open & all Mensa members may attend.

The meeting adjourned at 7:00 PM.

From the RVC

In my 35 years of Mensa membership, I have noticed that the favorite pastime of some Ms (very few, thank goodness) seems to be pontificating at length on subjects about which they know little or nothing. I don't know why they do this, perhaps in order to make themselves seem more knowledgeable, and hence more interesting, than they actually are, but for whatever reason, they insist upon doing so at every opportunity. Now, unfortunately, an opportunity has arisen which they find well-nigh irresistible.

Some of you are undoubtedly aware that American Mensa Ltd. has, for the last couple of years, been involved in a lawsuit against a foreign company which applied for trademark registration of a name which included the letters "mensa". AML opposed their application, and when they declined to make some modest changes in their logo, a suit was filed. All of this was a normal and rational reaction to an attempted infringement on our name, which we have spent a great deal of time, effort, and money to publicize over the years.

Last month this lawsuit finally came to trial, and while the jury found in our favor on the issue of our ownership of (and hence the right to defend) the trademarked name "Mensa", they were unable to award us monetary damages, due to an unfortunate ruling by the judge. Consequently, AML was unable to recover our attorneys' fees, which were much higher than anyone had expected at the commencement of the litigation, when it was believed that the parties would be able to reach a settlement. As a result, the AMC has voted to make some minor adjustments in the current year's budget to help offset the expense of the lawsuit.

Now, a notice of appeal has been filed, and thus the lawsuit is still on-going, so the AMC members, including myself, cannot yet divulge the details of the actual litigation, but I can tell you that the costs of the suit are being paid, and the budget adjustments are largely limited to details of administration affecting the way that the AMC and the National Office operate. There are a very few proposed new programs which will be postponed for a year or two, but no current member benefits will be affected. In other words, you will not even be aware of the changes that have been made.

There are, however, a handful of ill-informed and irresponsible members who have chosen to disseminate false and malicious rumors that Mensa is somehow "broke" and facing financial ruin. Nothing could be further from the truth. The AMC Finance Committee and National Office staff have done an excellent job of managing our resources so that the outcome of this litigation, whatever it may be, will have virtually no impact on the activities and benefits available to the membership. If you hear otherwise, it is from someone who is either ignorant of the facts, or deliberately trying to stir up trouble for their own amusement.
