History Student Wins Scholarship

The second in our series of three scholarship winning essays is the work of a doctoral student in history at Texas State University.

2009 Lester London Award Winner (for a graduate student in history) – Kyle Goyette

From my early childhood, I have been fascinated by history. Something about studying the past and how it affects our present and future has always appealed to me. As I grew older, I found myself reading biographies for no other reason than I found them interesting. While I realize that I must sound like a thousand other graduate students, the truth is that my initial love of history is what compelled me to follow history as a major in college and as a profession in graduate school. My undergraduate work only reinforced my determination to become a historian.

Although I have always loved history, it was not until graduate school that I learned the methods necessary to become a historian as opposed to someone who "likes history." I came to realize that, much like any profession, history requires certain skills; simply enjoying the work was not enough. As I began to learn the research and writing methods necessary to follow history as a discipline, I began my evolution from student to scholar. Above all, graduate school allowed me to grow from a person who loves history to a scholar who is able to practice it. I have already enjoyed the experience of presenting my first paper and am scheduled to present another in April while also working on having my first articles submitted for publication.

During my years at Texas State, I discovered my fascination with 20th century American politics and the struggle over the Equal Rights Amendment (ERA) in particular. My initial interest in the ERA led me to conduct research and eventually follow the ERA as my thesis. I found so many wonderful sources in the archives at Texas Women's University that I spent days there pouring through their materials. Upon returning to school, I immediately began writing and have not stopped. The research completed for my thesis on the ERA affords me the opportunity to think about how I will expand the work for my doctoral dissertation on the ways in which the battle over the ERA changed American politics. For my thesis, I am narrowing my scope to follow

the amendment's influence on Texas' political culture; however, I already know how I will expand the work to a national level for my dissertation. I find the fight over the ERA fascinating because it engendered such passion from Americans across the political spectrum and redefined the modern debate between the liberal demand for progressivism and the conservative demand for morality and traditional values. The defeat of the ERA was only the beginning of a discussion over gender roles and political rights which continues today.

I learned a great deal as an undergraduate, but graduate school was where I came into my own and began to thrive. Working with such prominent scholars not only reaffirmed my desire to become a historian, but also taught me the methods that I will carry with me while working towards my doctorate. I still love history, but now I am able to understand and appreciate it as a discipline instead of something simply in the pages of books. Graduate school not only gave me the opportunity to improve my writing and conduct independent research, it also taught me the tools that I will take with me throughout my career.

July ExComm Minutes

The regular monthly meeting of the Lonestar Mensa Executive Committee (ExComm) convened at 6:05 PM, July 8, 2009, at the Northwest Community Center, 2913 Northland Dr., Austin, TX. Attending were: President Ron Edelstein Chairman; Vice-President Don Drumtra Secretary; Treasurer Patty Drumtra; and Members-at-Large Paul Anderson, Kathie Lawler, and John Neemidge. The ExComm approved without debate the June 3 ExComm minutes published in the July Armadillo Literary Gazette (ALG) page 5.

Ron announced that he had appointed Skyler Kanegi as interim UT Mensa Student President (subject to election by the UT Mensa students).

Don reported that he and Fred Goertz attended the AG along with others from Lonestar Mensa. He offered a summary of what he learned at the AG to ExComm members after the meeting.

Patty reported that the group was currently in good financial health and provided the ExComm a written draft of the Second Quarter Report with the details for publication. The ExComm adopted the written report without debate subject to correction to the online version if any ExComm member had specific corrections. Financial reports are available to members on the LSM Website and by request; quarterly reports are also published in the ALG.

Kathie, Communications Chair, reported that she had begun an initiative to reconcile differences between the online calendar, the printed calendar, and the news cycle ASIE. The ExComm adopted a motion to change the "Calendar Editor" in the news cycle ASIE to "Calendar Coordinator" for consistency with the AML Editors Handbook. (ASIE 2009-10)

The Education Membership and Symposia Committees had no report. However, the ExComm discussed the August meeting and the need to get out publicity to the membership and the community about the program and the testing discount coupons available to be given away while they last.

Don, Bylaws Committee Chair, reported that we had received comments and corrections on our proposed bylaws. A meeting of the Bylaws Committee was scheduled for July 9 to discuss them.

John, LonestaRG Chair, reported we had five members sign up for the RG so far this July. He also plans to schedule a committee meeting later in July.

Don announced the next regular monthly ExComm meetings were scheduled for 6-7 PM, August 5, (first Wednesday), September 9, (second Wednesday, and the first Wednesdays in October, November, and December, at the Northwest Recreation Center multipurpose room.

ExComm meetings are open and all Mensa members may attend.

The meeting adjourned at 6:50 PM.

If you have been harboring any lingering doubts about the health and vitality of Mensa, the AG in Pittsburgh would surely have laid them to rest. With late registrants spilling over into two other hotels, the venerable Omni William Penn was completely taken over by the crowd of nearly 1,900 Ms, who met, debated, partied, learned, played, ate, drank, laughed and danced every day and night until the wee hours. What an experience!

AG Chairs Mary Lee Kemper and Marc Lederman and their team worked nearly non-stop to make this year's AG a rousing success. Region 6 was fairly well represented, as I encountered members from the New Orleans, North Texas, South Texas, Lone Star, Gulf Coast, and Permian Basin groups. Several people indicated that they were excited about my suggestion of a train trip to next year's AG in Detroit, so I'll start working with Amtrak right away to see if that is financially feasible. With or without a private rail car, I hope that all of you will at least give some thought to the possibility of attending next year. The AG is one of the things Mensa does best.

This year, of course, was my first AG as a member of the American Mensa Committee (AMC), and I soon found out that we were expected to earn our keep, with meetings all day and half the night on Thursday. That was pretty exhausting, but at least we got almost all the business out of the way on the first day, leaving the rest of the AG relatively free for more enjoyable pursuits.
