

#### **Don's Dialectics**

At the New Years party, a member asked me what I planned to do as LocSec—what were my goals for 2010? My response was, "to have fun." After all, was that not why I joined Mensa in 1975? One of the three purposes of Mensa is "to provide a stimulating and intellectual and social environment for its Members." Within that environment we can have fun.

What is fun? To some, playing bridge is fun. To others playing poker is fun, or quilting is fun, or listening to engaging speakers is fun, or collecting and discussing gems is fun, or talking with friends at a picnic is fun, or discussing solutions to the world's problems is fun. All these activities can be done without Mensa but many seem to be more fun when they may be shared among friends who have the similar interests and get our jokes. Do we need Mensa to have fun? Not necessarily. But with a supportive and non-threatening environment having fun seems to be easier.

So who creates this environment? Civic societies and their institution provide the environments and frameworks within which individuals are more or less free to have fun. It seems to work best when the framework is invisible to the individual-it is there for support and its parameters are unconsciously understood. Most of us want to see little of our government, but we want its institutions and its officers to be available when we need them. Do we expect less from Mensa? We expect our officers to maintain the environment, to manage the framework, to arrange meeting places for our meetings, to schedule speakers, to provide a calendar so we know what activities are available, to manage our money so we can buy charcoal and condiments for our picnics, and to keep the environment stimulating. In Lone Star Mensa, some of us are those officers-we are the volunteer coordinators who sustain the environment so that all of us can have fun. We maintain the environment and the framework-the bylaws, rules, and other elements of bureaucracy-which are necessary, just like they are in the American Society, but which should remain invisible to most of us

And what do I plan to do? I view my role as a coordinator of the coordinators—not a boss, not one who tells folks what to do, but one who provides other officers support by coordinating the activities of the officers of LSM. And playing that role is one of the ways that I have fun.

# <u>Bylaws Amendment Approved</u> <u>Now Accepting Board Nominations</u>

As Ron Edelstein announced on the LSM Announcement email list, the National Bylaws Committee approved our bylaws amendment and established an effective date of 23 January 2010. The Transition Section requires us to elect the 2010-2011 Board of Officers. We will be electing eight members to the Board, four to serve through March 31, 2011 and four to serve through March 31 2012. The elected board members will in turn elect the LocSec, Vice-President, and Treasurer from the board members we elect.

To start the election process, on January 13, the Loc-Sec appointed Janet Kres, Margaret Wofford, and Geri Neemidge as members of the Nomination and Election Committees and Janet as Chair.

### 2009 Annual Financial Report

We have had a good year financially. Overall revenue slightly exceeded expectations while expenses were 75 percent less than we had budgeted. The income statement shows the comparison between our budget and expenses for each of our programs. The low expense numbers show that we could have spent more and perhaps done more in each of our programs. Our balance sheet shows current assets of \$6,141 providing us sufficient resources for seed money for new projects. Long term assets include \$8,000 for the education fund, \$7,000 for the scholarship endowment, and \$3,000 held in reserve to support the 2010 RG. These funds provide us interest revenue to help support our programs although current interest has been significantly below what it has been in past years. Additional details on our finances are available on our Website. The ExComm adopted this report on 2010 January 13.

I have enjoyed serving as your Treasurer for the past two years and appreciate your support. I and hope to see you all at our events and activities in the future.

To recap the travel plans, Leslie and I plan to leave Dallas on Monday, 6/28 via Train 22, the Texas Eagle, which departs San Antonio at 7am, Austin at 9:31am, Ft. Worth at 2:20pm; Dallas at 3:40pm, and Longview at 6:15pm. Upon arrival in Chicago at 1:52pm on Tuesday, 6/29, we change to Train 354, the Wolverine, departing Chicago at 6pm and arriving at Dearborn no later than 11:59pm. Since the travel time from Chicago to Dearborn is only 6 hours, there is no sleeper on the Wolverine, and the extra fare for business class is probably not worth it.

Returning, we will leave Dearborn via Train 351 on Tuesday, 7/6, at 7:11am, arriving in Chicago at 11:24am, then changing to Train 21, which departs at 1:45pm. We will have 4 hours to do a very small amount of sightseeing in Chicago on the way to the AG, and I'll be glad to take anyone who wants to go on an excursion to the top of the Willis (formerly Sears) Tower, now the tallest building in North America, but I suggest you not make any plans to leave Union Station on the way

OK - the train to the AG is on! Thanks to some timely assistance from Austin Horowitz, the AG Tour and Travel Coordinator, we have an Amtrak fare code (No. X20B-981) that will give anyone traveling to and/or from the AG a 10% discount on the base fare. Note that those of us who are 62 and over will probably want to use Amtrak's Senior Discount (15%) rather than the 10% convention discount. Either discount will apply only to the basic rail fare, but not the additional charge for sleeping accommodations, but note that the sleeping car charge includes all meals on the train. Also, the convention discount is good for all travel to and from the AG from 6/27 through 7/8, not just for our group, so if you only want to ride with us part of the way or just in one direction, or you want to go by train but on a different day, you can still get the discount. However, note that the convention discount is not available online home, as we will have only 2 hours between trains.

Summer is Amtrak's busiest season, so I encourage you to make your reservations as soon as possible, either directly with Amtrak or through your travel agent.

In the meantime, membership renewals are due next month, so don't forget to get your renewal in to the National Office as soon as possible. Early renewals save money for Mensa that can be used for the support of valuable membership services.

- Ron reported that testing is scheduled for 9-Noon, January 16 and 23, at the Leander Public Library.

- Ron reported that the January 13 general meeting will be soapbox presentations and that we have tentative speaker for February 10.

- Don reported that Omni Hotel, Southpark, Austin had been selected as the location for the AML 2011 Colloquium on the Social Impact of computer gaming.

- The ExComm adopted a motion to postpone indefinitely any pending motions and other actions of the 2009 ExComm and adjourned sine die at 6:20 PM.
