GAULT SITE TOUR AND UPCOMING LONESTARG SPEAKER!

Dr. D. Clark Wernecke, Executive Director of The Gault School of Archaeological Research gave the tour, and it was incredibly informative and entertaining - so much so I asked him if he would come present at our upcoming RG - and he agreed! So if you missed the tour - be sure not to miss the talk!

He took us on a tour that included Clovis era and pre-Clovis era history, but also covered the really interesting timeline about the archaeologists' struggles to work this incredibly important site, starting in 1929. This site has found many surprises (I don't want to post too many spoilers in case you want to tour the site someday) that have kept archaeologists around the world on their toes - one of which is that between 1999 and 2002 more than 1.2 million artifacts were recovered - about half of them of Clovis age. The tour really was "Mensa worthy" as it made me constantly think and Dr. Wernecke used a lot of humor. Between demonstrating likely weapons used to hunt large game, debunking textbook myths of early man in this region, and telling us the quirks of various landowners of the site up until present day, we stayed interested and amused throughout the tour.

Wildlife spotted included a fox, a frog in the actual dig site, and the longhorn heifers! (Okay, not technically WILDLIFE, but we city folk got a kick out of it.) The heifers had newborn calves - one calved right before our tour showed up and we got to witness its first steps. Dr. Wernecke said of all the things people take photos of, they get more cow photos than anything else.

FROM THE RVC

Several years ago, I promised in this column that I would not hesitate to seek your advice if something came up on the national level that did not seem to have an obvious right or wrong side. In keeping with that promise, I must now ask for your guidance on a matter that is

currently scheduled to come before your Board of Directors at our summer Board meeting in Boston. The posted agenda for this meeting contains proposals for some rather extensive modifications to our current procedures, and I am faced with very difficult decisions on a few of the proposed changes.

The first change that is causing me some heartburn is a proposal that would solve the problem of filling mid-term vacancies in the office of Regional Vice Chair. New York law provides that an office which was elected by fewer than all of the voters cannot be filled by appointment, as we would do for a vacancy in any of the other Board positions. In order to avoid the expense of special elections, the Board has established a system whereby the local groups in a region which loses their RVC mid-term for any reason will be divided up among the neighboring regions until the next regular election. This process has not yet had to be used. Now it is proposed that the problem be solved in a different way: by having the RVCs elected nationwide, so that vacancies in that office can be filled by appointment just like the other offices.

The obvious drawback is that the majority of voters would be voting to choose between people they had

never heard of, for an office which would supposedly represent someone else.

The second proposal I am unhappy with comes from the Finance Committee. They want to avoid the necessity of periodic large dues increases by indexing dues for inflation. This proposal calls for automatic annual increases of 2.5%, beginning in 2015. I understand the need to offset inflation, but this idea seems to encourage financial irresponsibility. It also seems to assume no membership growth.

I would like to support our national leadership in these reforms, but I have some serious reservations about the wisdom of making some of these changes. If you have strong feelings about these issues, either pro or con, I would really like to hear your views before I vote on the proposals. Some of them, of course, require changes to the national bylaws, which would have to be ratified by the membership in the next election, but I don't want to vote for measures which I'm fairly sure the members will not approve.

You can read the exact wording of the proposed changes on the national website in the posted Agenda for the summer 2014 Board meeting. Please take a minute right now to look over these changes, as well as the rest of the revisions, and let me know if, on balance, you favor or oppose the proposals. New Business and Actions

- The board approved paying to mail postcards out to LSM members for whom we do not have email addresses. The board approved funding a party at Pinballz on June 13, 2014, which is expected to cost about \$600 or less.
- Leslie moved that all volunteers holding official LSM positions should submit to the Vice-President/Secretary of the board via email a monthly report or check-in at least five days before the board meeting, and any agenda items they need to add if they, or an appropriate representative, can attend the board meeting to discuss the agenda item. If they do not submit any report for three consecutive months with some sort of action item reported, then the board of officers should take action to either replace the volunteer or else decide if that position is still necessary to LSM. The motion passed unanimously.
- Geri appointed Patsy Graham as Membership Chair, unanimously passed by board
- Geri appointed Leslie as Webmaster, unanimously passed by board
- Ron moved that Leslie, as Webmaster, have complete control over the website subject to input from the board. The motion passed unanimously.

MEET THE WORLD CUP'S ENDANGERED ARMADILLO MASCOT

Will Fuleco, the cartoon mascot, help raise awareness for the endangered Brazilian three-banded armadillo?

Over the next several weeks, hundreds of millions of people around the world will sit and cheer in front of their televisions and computer screens as the 2014 FIFA World Cup takes place in Brazil. Some of the world's top athletes will be on display during the month-long soccer competition that runs from June 12 through July 13 — and so will the World Cup mascot, a Brazilian three-banded armadillo named Fuleco.

Over the course of the World Cup, it seems obvious that more people will see Fuleco than will see actual Brazilian three-banded armadillos. The rare animals, which live only in western Brazil, were thought to be extinct until they were rediscovered in a few remote locations in the 1990s. Today they are considered vulnerable to extinction, mostly due to habitat loss.

When FIFA announced Fuleco back in 2012, the organization said the mascot represented the World's Cup's lofty environmental goals. In fact the mascot's name is a play on the words Futebol (football) and Ecologia (Ecology). "One of the key objectives through the 2014 World Cup is to use the event as a platform to communicate the importance of the environment and ecology," FIFA Secretary General Jerome Valcke said at the time. "We are glad to be able to do so with the help of a mascot who I'm sure will be much-loved."

Unfortunately, FIFA's promise to make this year's competition the greenest World Cup to date hasn't necessarily lived up to reality. Brazil, which will also host the 2016 Olympics, has razed critical rain forests to make way for a new \$325 million stadium. And it has been said that travel for the month-long World Cup will be the equivalent of driving half a million cars around for an entire year.

That brings us back to Fuleco. A team of scientists recently called for FIFA to do more to protect the Brazilian three-banded armadillo. Specifically, they have called for FIFA to protect 1,000 hectares (about 4 square miles) of the armadillo's critical habitat in the Caatinga ecosystem for every goal scored over the course of the World Cup. "Protecting the remaining Caatinga is extremely urgent," José Alves Siqueira of the Federal University of the Valley of São Francisco said in a news release in May. "We want the choice of one of the Caatinga's most iconic species as the World Cup mascot to be more than just a symbolic one."

The move, if it actually happens, can't come fast enough for Fuleco's real-world cousins. Populations for this rare species — one of only two armadillo species that can roll into a complete ball — have dropped by as much as 30 percent over the past decade. That's not much to cheer about.

LONE STAR MENSA LONE STAR MENSA 2013-2014 FINANCIAL REPORT, APRIL 1 – MARCH 31

For this fiscal year we expected revenue of \$6,184 all from the National Office. We actually received \$7,165 from all sources, a difference of \$980. We expected a lower growth of membership than we actually had. We began the year with 515 and ended with 663 members.

Revenue was better than we anticipated for all four of our programs, overall exceeding our expectations by 15 percent. Conversely, expenses overall were only 78 percent of budget with no expenditures for membership recorded for the entire year. The net result of high revenue and low expenses was a surplus of \$2,000. That would normally be considered good but in our case it indicates that we were putting money in the bank instead of using it to benefit our members. See the LSM Website for more detail.
